

Envelope rebate incentives and conditions

For a limited time, earn a 50% bonus for rebates when upgrading completing building envelope retrofits. Upgrades must be completed and submitted for payment by November 15, 2021.

Additional requirements

1. Building must have air conditioning and/or electric heat in the affected building area to qualify.

2. Incentive is per square foot of *component* area, not building area.
3. Listed required performance criteria are for the entire window assembly (including frame), not just center-of-glass (COG) rating. Required performance criteria must be validated by inclusion within NFRC certified product database or validated by NFRC accredited laboratory or approved calculation entity. Required U-values are for all window orientations. Required SHGCs are for windows within 45 degrees of West, South, or East.
4. Existing windows must be clear and either single or double pane. Window films must be professionally installed. Incentives are only for windows within 45 degrees of West, South, or East (north facing windows do not qualify).
5. CI stands for continuous insulation (i.e. no thermal breaks such as studs, rafters, etc.). LS stands for Liner System. Product rating must be met or exceeded to qualify; no partial improvement can be applied. R-value is an average across total square footage being insulated. Overall assembly R-value (including existing insulation) may be accepted on a case-by-case basis (provide assembly R-value calculations).

Limited time 50% bonus incentive details and requirements:

Starting June 1, 2021 Efficiency Works Business is offering a 50% bonus on rebates for efficiency upgrades in the following categories: Food Service, Grocery, Office and appliance, Building envelope, Cooling, VFDs and Water retrofits. To qualify for the bonus efficiency retrofit incentives, upgrades must be completed and submitted for payment by November 15, 2021.

- Qualifying rebate categories: Food Service, Grocery, Office and appliance, Building envelope, Cooling, VFDs and Water retrofits
- Electric efficiency incentives are available to commercial electric customers of Estes Park Power and Communications, Fort Collins Utilities, Longmont Power & Communications or Loveland Water and Power
- Water efficiency incentives are available to commercial water customers of Fort Collins Utilities, City of Longmont or Loveland Water and Power
- Bonus does NOT apply to lighting retrofits, custom upgrades, new construction projects, or building tune-up incentives
- Efficiency projects started after June 1, 2021 are eligible based on a rebate pre-approval date or the date listed on the contract (invoice) if the project did not require preapproval
- Total incentive amounts over \$10,000 require pre-approval before efficiency upgrades begin
- Upgrades must be completed and submitted for payment on or before November 15, 2021
- Total incentives are limited to 100% of a project total upgrade cost
- Efficiency Works Business maximum incentive limits will apply per project and customer per calendar year
