

## Envelope rebate incentives and conditions

For a limited time, a 50% bonus is available for rebates when completing building envelope upgrades. Upgrades must be completed and submitted for payment by November 15, 2023.

### Additional requirements

1. Building must have air conditioning and/or electric heat in the affected building area to qualify. New construction and major renovation projects are not eligible for building envelope incentives.
2. Incentive is per square foot of *component* area, not building area.

3. Listed required performance criteria are for the entire window assembly (including frame), not just center-of-glass (COG) rating. Required performance criteria must be validated by inclusion within NFRC certified product database or validated by NFRC accredited laboratory or approved calculation entity. Required U-values are for all window orientations. Required SHGCs are for windows within 45 degrees of West, South, or East.
4. Existing windows must be clear and either single or double pane. Window films must be professionally installed. Incentives are only for windows within 45 degrees of West, South, or East (north facing windows do not qualify).
5. CI stands for continuous insulation (i.e., no thermal breaks such as studs, rafters, etc.). LS stands for Liner System. Product rating must be met or exceeded to qualify; no partial improvement can be applied. R-value is an average across total square footage being insulated. Overall assembly R-value (including existing insulation) may be accepted on a case-by-case basis (provide assembly R-value calculations).

#### Incentive details and requirements:

- Electric efficiency incentives are available to commercial electric customers of Estes Park Power and Communications, Fort Collins Utilities, Longmont Power & Communications or Loveland Water and Power
- Water efficiency incentives are available to commercial water customers of Fort Collins Utilities, City of Longmont or Loveland Water and Power
- Total incentive amounts over \$10,000 require pre-approval before efficiency upgrades begin
- Total incentives are limited to 100% of a project total upgrade cost
- Efficiency Works Business maximum incentive limits will apply per project, see Program Guide for details

#### Limited time 50% bonus incentive details and requirements:

Starting April 15, 2023 Efficiency Works Business is offering a 50% bonus on rebates for efficiency upgrades in the following categories: lighting, food service, grocery, office and appliance, building envelope, cooling, VFDs and water. To qualify for the bonus efficiency incentives, upgrades must be completed and submitted for payment by November 15, 2023.

- Qualifying rebate categories: lighting, food service, grocery, office and appliance, building envelope, cooling, VFDs and water
- Bonus does NOT apply to custom upgrades, new construction or major renovation lighting or envelope projects, or building tune-up incentives
- Efficiency projects started after April 15, 2023 are eligible based on a rebate pre-approval date or the date listed on the contract (invoice) if the project did not require preapproval
- Upgrades must be completed and submitted for payment on or before November 15, 2023
- All standard incentive requirements and maximums apply to projects eligible for the bonus incentive
